##### • SCOPE OF THE ACTION

###### **Personal Scope:**

###### **Territorial Scope:**

The Action is valid throughout the province of Málaga.

###### **Time Frame:**

The Organizers reserve the right to suspend, delay, cancel, or modify the time frame at any time before its conclusion, if justified.

##### • PARTICIPATION REQUIREMENTS

- (i) meet the requirements listed in Section I of these Terms; and
- (ii) properly enter the giveaway within the designated time frame.

All such individuals are collectively referred to as "Participants."

#### • **MECHANICS OF THE ACTION**
